01. MINUTES

R. Blackburn advised that he had investigated Parishioners attending Willen Hospice and confirmed that the number sufficed and validated the charities support. This had been queried by Cllr Dransfield last year. Question and answers were duly noted. The history of the Charity was requested to be added back into the Parish's new website.
