The minutes of the previous Annual Meeting of Council held on Monday 21<sup>st</sup> May 2012 were **AGREED** as a true and correct record and signed by the Chair.

Cllr Andy Dransfield stated that the Parish Clerk's job description and person specification had been removed from the Parish website. The Chair said he doubted this was correct and would check. Cllr Dransfield requested that a copy of the Job and Person Specification along with the Contract of Employment for the Parish Clerk is sent to him. The Chair said he would arrange for this.

Cllr Dransfield informed the meeting that he had not been asked to an Editorial Team Meeting regarding the Newsletter. The Chair said that all members had been asked to supply material for the Newsletter. There had not been any meetings about the Newsletter but drafts had been circulated on several occasions by email to all

members during the preparation of the newsletter. A number of Councillors had produced content and made comments and amendments on the drafts.

#### **NOTED**

#### 10/13 Questions from Members of the Public:

Mr John Howe asked how Loughton Parish Council could justify an increase in the Precept?

Why did Loughton Parish Council need to increase the hours of the Parish Clerk?

The Chair replied that he had had a lengthy email exchange with Mr Howe where he had raised the same points.

The Chair informed the meeting that the rise in Precept meant £30 in a year for a Band D property, which was less than half the average for MK Parishes so this was objectively not a high level. Loughton Parish Council had been largely moribund in the past. The Parish Council had previously not attempted to engage with local residents or be at all active in the local community and formerly was largely unknown. As a result Loughton did not have the same level of facilities that other areas in MK enjoyed e.g. play areas and community events. The Chair had noted in correspondence with Mr Howe that he did not seem to have any insight into the workload of the Parish Clerk and was expressing a view without having made any enquiry as to the position.

The Chair said he had appreciated the support of BALC during the year (1) they were helpful when the former Clerk became unavailable at short notice for two meetings of the Parish Council – in that they had supplied contact details for a qualified locum Clerk which had enabled meetings to go ahead. Also, (2) when dealing with the appointment of the new Parish Council they had assisted with the recruitment process and also advising on the appropriate contract of service of the Parish Clerk. They also (3) provided useful training courses so that Members of the Council could be trained on how to be effective and to understand their responsibilities – such as the Code of Conduct. The Chair acknowledged that non-members could attend the training for an additional fee but if no Councils supported the organisation it might not be there in future.

The Chair pointed out that the quote was for a visit and a letter only and it did not include preparation of the financial statements (i.e. P&L & balance sheet) as per previous years. It was agreed the quote from Connollys was unclear and would have been better if it had detailed the work which would be included. It was mentioned that Connollys had paid for advertising in the last two newsletters although Cllr Hoyle stated he thought it was criminal corruption for this to be taken into account. The Chair pointed out advertising was available freely on a commercial basis and Connollys had received full value for their payments. The Chair's mentioned there would likely be additional costs of a change in auditor to set up the audit and during the year it was likely there would be a call for professional advice

Cllr Andy Sargent reported on planning application (12/02543/FUL 22 Greenhill Close Loughton Milton Keynes MK5 8DG Part change of use from dwelling house to childminder use.) which Milton Keynes Council's Development Control Committee had recently refused.

Cllr Sargent said that had visited the neighbour to the above property who is now keeping a diary of all activity.

#### 21/13 Questions from Members of the Public:

Mr Stephen Smith raised the following points:

What are the financial benefits in relation to the part of the Milton Keynes Parks Trust land in connection of the redevelopment of the Badminton Centre?

The Chairman responded and went into the background regarding the Milton Keynes Parks Trust and the transfer of their land to the Badminton Centre.

Mr Smith said the new development at the Badminton Centre site is likely to result in significant alteration of the existing landform and could have an impact on the nearby woodland vegetation.

Mr Smith said it would be useful to know the current land ownership of the Great Holm Village Green and the landscape management responsibilities. Is the area privately or publicly owned? The Parish Council replied – the land is owned by Mk Council

#### NOTED

#### 22/13 Presentations:

a) Update report on the Scarecrow Trail by Julienne Hanson from All Saints Church, Loughton

There are fifthly nine (59) entries twenty nine (29) are adults and families, eight (8) children, ten (10) businesses and twelve (12) schools and Children's organisations. The trail has been provisionally mapped out; the extended trail is about five (5) miles long. A car trail is being worked on to take in the longer route.

Julienne will be checking to ensure the trail is suitable for wheelchairs and mobility scooters. There will be certificates for those who complete the trail.

The prizes will be vouchers to spend in leading Milton Keynes stores rather than having cash prizes.

Three (3) Judges have been appointed from Milton Keynes Arts Gateway and the Milton Keynes Gallery.

Raffle tickets will be on sale for 50p each prizes have already been donated with more to follow nearer the event.

The event will be taking place between 10:00am – 5:00pm pm on Saturday 29<sup>th</sup> June and Saturday 6<sup>th</sup> July 2013 and Sunday 30<sup>th</sup> June 2013 11:00am – 5:00pm All Saints Church will also be open to visitors with all sorts of activities taking place.

On Saturday 6<sup>th</sup> July between 7:00pm – 10:00pm there will be a bring and share supper with various activities taking place tickets will be available soon.

A blog has been set up to keep everyone in touch with what is happening.

The Chair thanked Julienne Hanson for her presentation.

b) Report from PC Albert Bernard of Thames Valley Police

In the absence of PC Albert Barnard PCSO Gemma Harmycz presented the report instead.

In Great Holm there were twenty eight (28) offences last month seven (7) were priority crimes, two (2) of which were a burglary in Haddon and criminal damage including graffiti at Lodge Lake.

There were four (4) priority crimes in Loughton, criminal damage in Glebe Close, a burglary in London Road, and two (2) thefts from insecure vehicles one (1) in Holmcroft Court and another at the Milton Keynes National Bowl.

There then followed questions by members.

The Chairman thanked PCSO Gemma Harmycz for her report. **NOTED** 

c) Rachel Brain, Project Officer Green Deal and Communities Volunteer Manager of the National Energy Foundation, Knowlhill.

Cllr Andy Dransfield declared a personal interest in this agenda item as he is a Milton Keynes Council representative for the United Sustainable Energy Agency.

The Western Power Distribution Neighbourhood Electricity Demand Challenge is a new project funded by OFGEM.

A total of ten (10) neighbourhoods are being sought to trail different methods of managing electricity demand from between fifty (50) and two hundred and fifty (250) homes all connected to the same substation. Monitoring the data of the substation will be used to measure the effects of the local projects.

Neighbourhoods that have shown any positive impacts on their electricity use will be awarded between £2,000 and £5,000 to use for community projects.

Each community group will be asked to volunteer and design and implement from their resources a range of activities and monitor and evaluate their project as regards influencing the communities' use of electricity.

This project will start in August/September 2013 and could last until July 2014.

There then followed questions and statements from members.

The Chairman thanked Rachel Brain for her presentation.

#### **RESOLVED**

That Loughton Parish Council endorse this project and will cooperate with the National Energy Foundation on any publicity material and in holding a public meeting, and that the local residents should decide on how the possible £2,000 - £5,000 monies is spend in their community. No expenditure by the Parish Council was being sought.

#### 23/13 Community Asset Transfer:

a) To report on the meeting held on Friday 26th April 2013 with Officers at Milton Keynes Council regarding the Great Holm Community Centre

The Chairman informed the meeting that that none of the trustees were able to be present.

Having looked at the accounts it appears that the Community Centre receives about £9,500 income per annum and spends about £10,500 on salaries (cleaning and caretaking) approx per annum. Therefore the operation runs at a small deficit which could be closed with some small raise in hire charges

Last year the Community Centre Company had received an £11,760 grant from Milton Keynes Council for improvements, but this is not guaranteed in the future. Cllr Dransfield said if he has his way it will stop.

The Trustees have made it known that they are not willing to take on any of the external repairs. If the Parish Council takes over ownership therefore, it will take on the future repairing liabilities of the premises and may well have no support from MK

Council. The current premises look somewhat run-down and uninspiring, but nevertheless are an important community asset in Great Holm.

Milton Keynes Council have now put the asset transfer process on hold as no interest has been shown from anyone who wishes to take the property on. The Parish Council are the only likely bidder. The Parish probably has the option of proceeding to acquire the freehold should it want to.

There was a discussion as to whether the Parish Council should acquire the premises. Cllr Dransfield said if the Parish Council was taking on the Loughton Sports ground and associated premises then why not take on the Great Holm Community Centre too. He said it was like choosing to favour one child but not another child and they should be treated equally.

The Chairman noted these comments but said that further investigations should be made to assess the potential liabilities the Parish Council would be exposed to. A local architect had agreed to view the premises with the Chairman and to advise on the costs which might be incurred for long term renewal and repair liabilities. Further consultation could be carried out as to whether the community wants the premises acquired by the Parish Council or not.

#### **NOTED**

b) To discuss and consider the Heads of Terms for the Loughton Sports and Social Club and Sports Ground.

The Chairman informed the meeting that heads of terms had been agreed (subject to approval of the Parish Council) for the freehold of the Loughton Sports ground and associated premises and car park to be transferred to Loughton Parish Council for a sum of £1. There will be a clawback by Milton Keynes Council for a period of twenty five (25) Years if the Parish Council wished to dispose of the asset.

There will be a £10k commuted sum paid to the Parish Council for the repair of the Car Park. Full details are set out in the draft Heads of Terms.

#### **RESOLVED**

To approve the Heads of Terms to acquire the freehold of the Loughton Sports ground and associated premises and car park and proceed with the transaction

c) To approve a quote for legal services from Geoffrey Leaver Solicitors relating to the Loughton Sports grounds etc.

The quote received from Geoffrey Leaver Solicitors relating to all the legal work regarding the Loughton Sports and Social Club is £1,750.00p plus VAT for dealing with the transfer and registration, plus £330.00 for the local searches.

#### **RESOLVED**

To agree to the quote from Geoffrey Leaver Solicitors of £1,750.00p plus VAT for dealing with the transfer and registration of the Loughton Sports ground etc, and £330.00 for the local searches.

# 24/13 To consider changing the name of the Parish Council to Loughton and Great Holm Parish Council:

There was a discussion of this proposal. This had been considered by the Council previously when it had been agreed to adjourn the proposal for further consultation with local residents before there was any decision. Since then the issue had been featured in the spring newsletter and an online poll had been promoted. 41 residents had voted with 31 in favour of the proposed change and 10 against – i.e. 75% in favour to 25% against. This ratio had now stayed pretty constant as more votes came in. It was suggested this indicated there was generally broad support for the proposal.

Cllr Dransfield spoke against the resolution. He said the name of the Parish Council had been as it is for a very long time and we should be very slow to change it. He said the poll was too small to carry any real weight. He said this was a long meeting which had now lasted to a late hour and it was not a good time when members were tired to make a profound decision of this nature. He called for the resolution to be adjourned for further consideration on another occasion.
