The Highways officer has reported that although the bridge belongs to Milton Keynes Council, it goes over Network Rail assets. Network Rail have required the change in style of the lighting to reduce the glare for train drivers as a matter of safety. One light was vandalised, and a full height replacement was installed. The Highways dept stated that the lighting cannot be changed due to the requirements by Network Rail.

FC188/18 To consider awarding a grant of £500 to All Saints Church, Loughton to fund advertising, leaflets and prizes for an 800th anniversary summer fete involving community groups (see attached)

FC189/18 To consider awarding a grant to the Friends of Holmwood PTA for £1000 to contribute to the cost of entertainment at a summer fete, for children's equipment and a disco or trip for school leavers/joiners (see attached)

FC190/18 To note that the Local Government Pension Scheme contribution has been increased to 25.1%. This is the decision of the actuary because Loughton Parish Council did not pay an exit payment when they ceased to participate in the Fund in 2013. The historic liabilities are currently being funded for by the active employers of



the Small Scheduled Bodies pool, and 25.1% includes the current employer's contribution of 16.8% and a contribution to the deficit since 2013.
